- Test conditions:

Overall migration: 10 days at 40°C, used simulants A, B, 95% ethanol and 2 days at 20 °C simulant Iso-octane Specific migration melamine: 10 days at 40°C, used simulant B (repeated use) Specific migration formaldehyde: 10 days at 40°C, used simulant B (repeated use)

Ratio of food contact surface area to volume used to determine the compliance of the article:
Volume ratio = 6 dm²/ kg

This declaration is valid for the products delivered by us as specified above. The Regulation (EU) 10/2011 provide a guideline for the selection of test conditions to be used for various food products.
