## MANUFACTURER'S DECLARATION

### GLASS CONTAINERS AND TABLEWARE

Declare that all glass articles branded Bormioli Rocco and Bormioli Luigi comply with EU Regulation 1935/2004, and they are manufactured in accordance with EU Regulation 2023/2006.

The items comply with the Danish limit values for release of lead and cadmium:

Limit values for lead and cadmium from ceramic and enameled articles as well as glassware, cf. Danish Order 681 on food contact materials and on provisions for penalties for breaches of related EU legislation:

<sup>1)</sup> Mugs and similar articles to be drunk from must comply with both the requirements of category 1 for transfer from the mouth edge, and the requirements of category 2 for the rest of the article.

The validity of this statement starts from the signature date and it will be revised only following substantial changes in the manufacturing of the material which could modify the essential requirements or with regard to regulation amendments.
